The Menokin Foundation was featured this fall in the Arts section of *The Wall Street Journal* (10/28/2020). The article focused on Menokin's unique philosophy and approach to the preservation of their buildings and site. The two examples used to illustrate Menokin's "dynamic preservation" approach were the Glass House project and the [Remembrance Structure](#) both of which Reid Freeman has actively participated in. He served as a member of the advisory council for the contemporary glass and steel scope of the Glass House and as chair of the buildings and grounds committee during the project design phases. Reid was also the architect and designer of the Remembrance Structure that was completed in 2018.

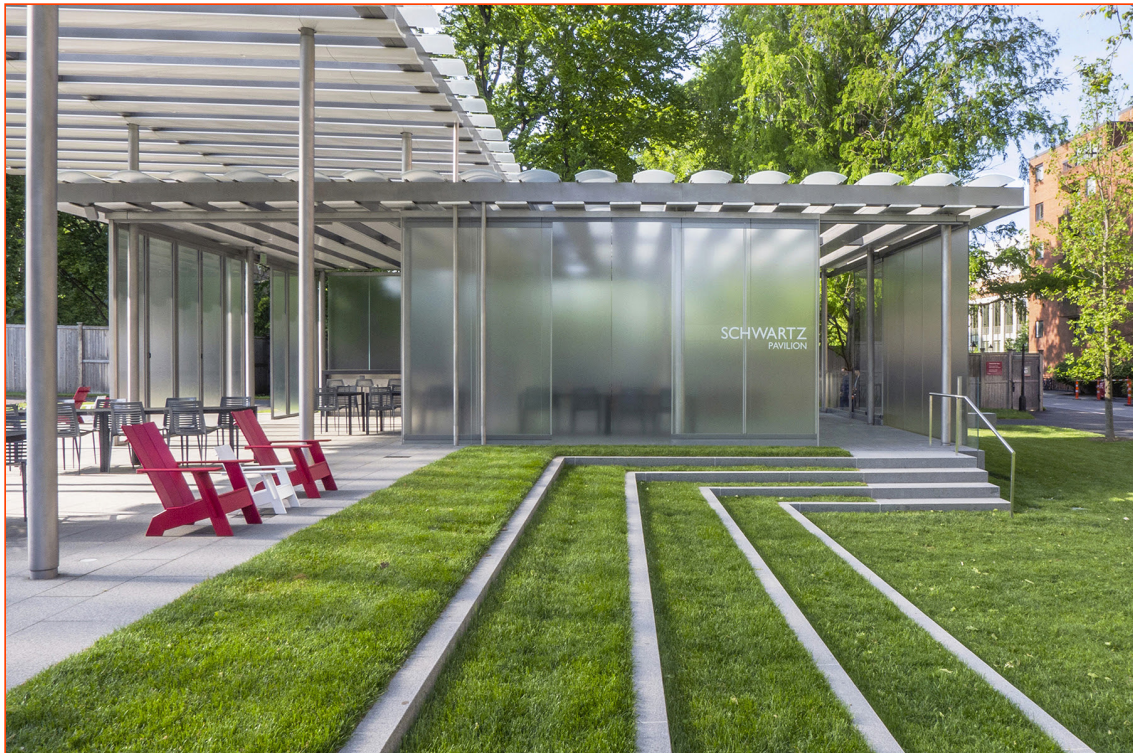


REMEMBRANCE STRUCTURE ON THE GROUNDS OF THE MENOKIN FOUNDATION, WARSAW, VA

The Menokin Remembrance Structure and REID Architecture PLLC received a [2020 New York State Design Honor Award](#) in the Pro Bono submission category in December of 2020. Reid Freeman also served on the jury for the 2020 AIA Virginia Design Awards.

PROJECTS

REID Architecture PLLC continues design work for the Menokin Foundation on the [Gathering House](#), a conference center and small auditorium, to allow the foundation to expand its educational programming and to host events centered around the Glass House project that is currently under construction. Small prefabricated Cross Laminated Timber (CLT) [guest cabins](#) are also in design and planned to support future events on the grounds of Menokin and to house visiting scholars and artists participating in programs planned for late 2021 and beyond.

REID Architecture PLLC and Reed Hilderbrand (landscape architects) are currently finishing up concepts and planning work for the Forest Theatre and Coker Arbor at UNC in Chapel Hill, NC. The materials produced in this phase will set the scope and budget for the renovation, expansion, and upgrades to two treasured outdoor spaces in the community and campus. Fundraising efforts and design phases are scheduled to begin in spring of 2021.

New residential projects are currently in design for a waterfront house in Fleeton, Virginia, and additions to houses in Amagansett, Sag Harbor, and Stone Ridge in New York. And lastly, construction work has been completed for additions designed for a house in Greenwich, Connecticut.
